On Tuesday, June 15<sup>th</sup> from 8:00-10:00, we will be hosting our final (second dose) vaccination clinic of the 2020-2021 school year. Special thanks to our partners at the Cayuga County Department of Health and East Hill Medical for facilitating vaccinations for our school community.
